### LEILA SALMON ADVOCATE OF THE YEAR AWARD

*In recognition of an advocate whose dedication and leadership has made an impact on the availability, accessibility, and/or delivery of mental health services nationally on behalf of New York State.*

#### **Linda Rosenberg, MSW**

*President and CEO*

*National Council for Behavioral Health*

Linda Rosenberg is a national expert in the financing and delivery of mental health and substance services. Under her leadership, the National Council for Behavioral Health has become our nation's most effective advocate for behavioral health prevention, early intervention, science-based treatment, and recovery. Harnessing the voices of the 10 million adults, children, and families served by the National Council's 2,500 member organizations, Rosenberg helped secure passage of the federal parity law, expanded integrated behavioral and primary care services, introduced Mental Health First Aid in the U.S., and built an array of organizational, clinical and workforce improvement initiatives. The National Council's strong support of the Mental Health Excellence Act will result in the first comprehensive effort to establish community accountability for the health of people with serious mental illnesses and addictions, the consistent utilization of evidence-based practices, and the standardized measurement of outcomes. Rosenberg was Senior Deputy Commissioner of the NYS Office of Mental Health prior to joining the National Council. She has over 30 years experience in designing and operating hospitals, community and housing programs, and implemented New York's first Mental Health Court. Rosenberg serves on an array of boards of directors and is a member of the Executive Committee of the National Action Alliance for Suicide Prevention.

#### **Jeff Wise, JD**

*Award Given Posthumously*

Jeff Wise, former Executive Director of the NYS Justice Center for the Protection of People with Special Needs, worked for more than 25 years on issues of New York public policy, legislation and advocacy involving issues touching on multiple underserved or special populations. During his career in public policy, Jeff was engaged in myriad policy and legislative issues. He had extensive experience in advocacy efforts, to which he brought his skills in negotiation, legislative bill drafting, research studies, and policy papers. From 2007-2013, Jeff served as President & CEO of the New York State Rehabilitation Association, a statewide association advocating for providers serving individuals with developmental disabilities and behavioral health challenges. Jeff was an active member of the Timothy's Law Campaign, a coalition of organizations who successfully won the passage of New York's mental health parity provisions now in state insurance law. Jeff was also active in authoring legislation regarding homeless policy, rent increase exemptions for people with disabilities living in rent-regulated or subsidized housing and other matters involving underserved populations.
